Sydney for Kids Directory Terms and Conditions

1. Fees

The fee for a listing (up to three activities) in the Sydney for Kids Directory costs \$50 per annum. All fees are inclusive of GST and must be prepaid by the business / organisation seeking listing (the "Advertiser"). These fees are subject to change at the discretion of the publisher of the Directory (the "Publisher").

2. New Listings

Payment of the fee for the total contract period must be forwarded to the Publisher together with completing the Application Form online.

The Publisher reserves the right to check the details on all application forms and to make all reasonable inquiries to satisfy itself that the Advertiser conducts a bona fide business matching the description on the application form.

The new listing will be published in the Directory in the week following receipt of payment.

3. Renewal of Listing

The Publisher will forward an invoice for renewal of the listing, prior to the expiry of the contract period. The Publisher must receive payment of the fees within 14 days of the date of invoice. The Publisher cannot guarantee continuity of a listing if payment is made after the expiry of the contract period.

4. Denial/Removal of Listing

The Publisher may, in its sole discretion, deny listing to any new applicant in which case the Publisher will refund the contract fee to the applicant.

The Publisher may remove a listing from the Directory at the end of the contract period if the renewal fees have not been received in accordance with these terms and conditions.

The Publisher may remove a listing from the Directory during the term of the contract if it comes to the Publisher's notice that the business does not in essence match the description on the application form or if the Advertiser's business or website is considered by the Publisher to be unsuitable for a child related site.

The Publisher will be under no obligation to refund any money to the Advertiser if removal of the listing is done pursuant to this clause.

The Publisher will not be liable for the failure of the listing or any part thereof failing to appear or due to errors or problems with the Publisher's web site or the Internet generally.

It is the Advertiser's responsibility to keep the details in the listing up to date.

The Advertiser acknowledges that third parties have access to the information in the Directory and that the Publisher cannot be held responsible for any use made by a third party of that information.
